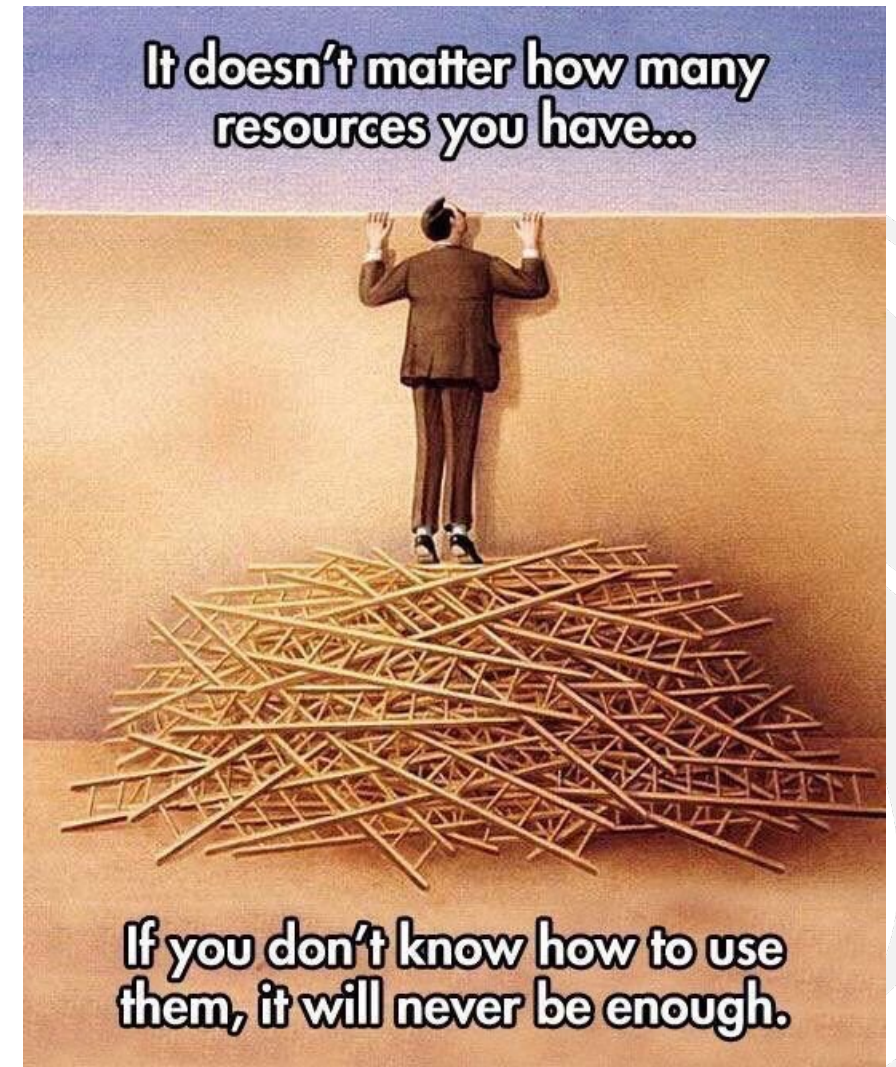

Information Literacy (IL)

The Association of College and Research Libraries defines information literate people as those who “*recognize when information is needed and have the ability to locate, evaluate, and use effectively the needed information.*” As the world moves toward a knowledge-based economy, IL becomes a crucial component of preparing us for the lifelong learning that current and future job markets demand.

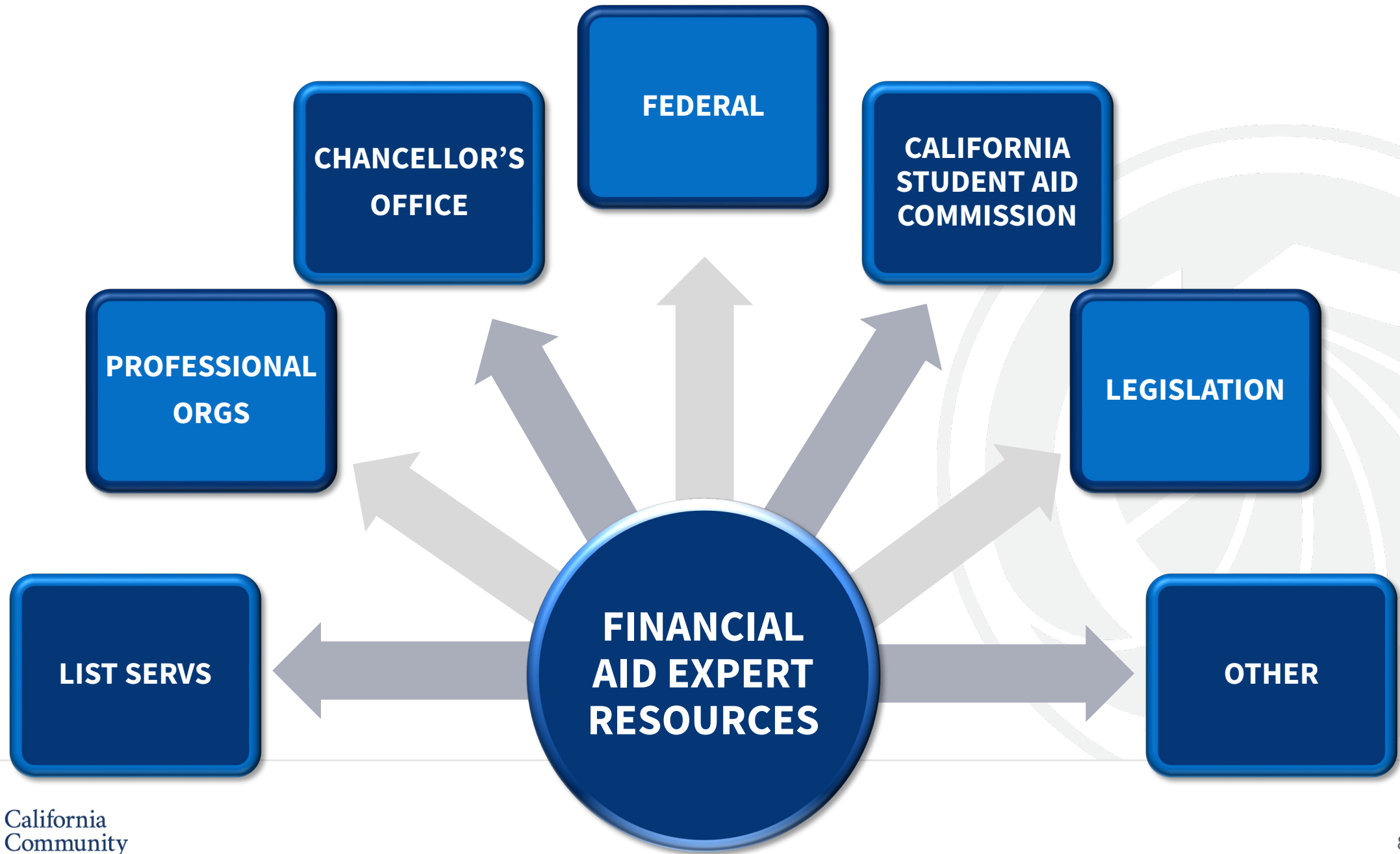
Information Literacy Skills

- **Identify** information needs and determine the extent of information needed.
- **Locate and retrieve** appropriate sources of information.
- **Evaluate** information and its sources critically.
- **Synthesize** the information retrieved, integrate it into one's current knowledge base, and successfully apply it to the original information need.
- **Present and translate** this newly acquired knowledge so that others can use it.



Questions to Ask

- Is this a federal or state financial aid program?
- Do I need an answer to a specific question or just an overview of a topic?
- How timely do I need the information?
- Do I need the source of a particular guideline?
- Who needs the information? Myself, students, an administrator, etc?

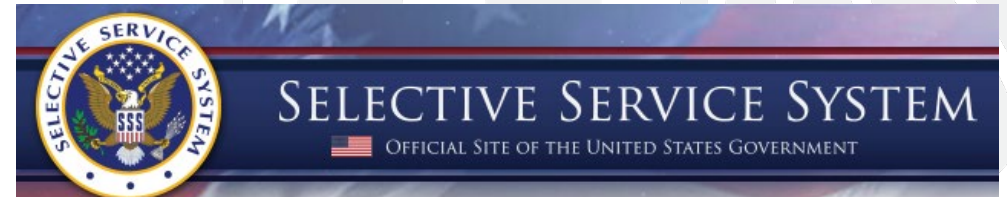
